Joyner Library welcomes David Durant back to the library after his return from active duty in the Army National Guard. After receiving an advanced degree in history (MA in Modern European History, University of California, Los Angeles, 1993), David says librarianship seemed an intriguing way to find gainful employment. David earned a Master's of Science in Information (Library and Information Services) from the University of Michigan in 1999, and came to Joyner Library as

federal documents coordinator and reference librarian. David enlisted in the Army National Guard in September 2005 after age statutes were changed because "I felt like I needed to do this at this point in my life and do my part for my country." He joined a heavy brigade combat team out of Clinton, NC and was on active duty for 17 months. David returned from deployment in January 2010 and to Joyner April 1st. We thank David for his military service and welcome him as he rejoins the Joyner team

as Collection Development Librarian for the Social Sciences and Federal Documents. In addition, David will provide liaison service effective July 1 to Anthropology, Communication, Military Sciences (and ECU's ROTC programs), Political Science, Psychology, Security Studies, and Sociology. David plans to settle into his new job and do his best for the library. Of the military experience he says "exposure to new software will benefit my career and working with young college people will be easier."

### Archival Online Journals

ast e-newsletter an article on Archival Online Journals alerted readers to recent acquisitions of several wonderful online journal packages. The news this issue is just as good, if not better! Due to the recent allocation of one-time funds from Academic Affairs, we have again been able to significantly expand our e-resource backfile access. The library is grateful for the opportunity to radically increase the scope and depth of scholarship available for our faculty and students. Recent purchases include the following:

Elsevier ScienceDirect Journals: full backfile access.

Through ECU's Freedom Collection subscription we already had access to virtually all El-

sevier journal content published from 1995 to present (more than 2,000 journals!),

and, through previous purchases, ECU had access to the older issues of journals in a number of subject areas. The current acquisition completes our archival holdings so that ECU now has access to virtually all Elsevier journal content from inception to the current issue.



Taylor & Francis Journals: full backfile access. Previously,

ECU's access to these journals was limited to individually subscribed journals and generally extended back only until 1997.

The current acquisition expands our holdings by adding all materials published in 1996 and earlier. For non-subscribed journals, access extends from inception to content published in 1996. For current subscriptions, access extends from inception to the current issue.

Emerald Journals: full backfile access. Previously, ECU's access to Emerald journals extended back to the mid-1990s. The current acquisition expands this access so that ECU now has access to more than 100 Emerald journals from their inception.

Sage Journals: full backfile access. Previously, ECU had subscribed to a large package of current content, and purchased all backfiles that were

available in 2007. However, since then, Sage has added archival content for 24 titles to which ECU did not have access. This gap has been filled so that ECU now holds virtually all Sage journal content from inception to current issues.

#### SSAGE JOURNALS Online

Journal of Fluid Mechanics (Cambridge University Press): Previously, online access was from 1997 to present. With the purchase of this archive, ECU has extended online access back to volume one, issue one, in 1956.

Wiley-Blackwell Backfiles: ECU has purchased two new backfile subject collections: Psychology (45 journals) and History and Archaeology (16 journals). Access to the titles in these collections is generally from inception to 1996. ECU has also purchased the full backfile holdings for Angewandte Chemie (International Edition in English). These new collections are added to last month's purchases of the Geography and Development, and the Aquatic Sciences and Fisheries collections, and an earlier year's purchase of the Chemistry Societies' Backfile. Other Wiley backfile collections were purchased by Laupus Library, and include Nursing and General Medicine.

### Libraries Faculty Open Access to their Scholarly Articles

On March 4, 2010, the faculties of both Academic Library Services and Laupus Health Sciences Library voted to endorse a resolution indicating our commitment to share our research as broadly as possible. To that end, the resolution below encourages library faculty to seek out open access publishing opportunities whenever possible, and to archive permissible versions of our publications in The ScholarShip, East Carolina University's institutional repository. Through The ScholarShip, ECU's research output can be collected and archived in one home space, and made freely available to anyone, any time. Our hope is that other units on the ECU campus will consider similar resolutions as the open access movement evolves. The full resolution is as follows:

We, the faculty of Academic Library Services and William E. Laupus Health Sciences Library of East Carolina University, resolve the following: To disseminate our scholarship as broadly as possible. We endeavor to make our scholarly work openly accessible in conformance with open access principles. Whenever possible, we make our scholarship available in digital format, online, free of charge, and seek copyright and licensing options that will permit us to do so.

To deposit our scholarly work in our institutional repository, The ScholarShip, at the earliest possible opportunity.


To seek publishers whose policies allow us to make our research freely available online. When a publisher's policies do not allow us to make our research freely available online, we resolve to engage in good faith negotiations with the publisher to allow deposit of peer-reviewed, preor post-print versions of our scholarly work in The Scholar-Ship.

This resolution, however, gives us the latitude and individual discretion to publish where we deem necessary, given our career goals, intended audience, and other reasonable factors.

The resolution applies to the scholarly works authored and coauthored while faculty are employed at Academic Library Services and William E. Laupus Health Sciences Library, beginning with works published or submitted for publication after March 15, 2010.

Resolutions such as the one above are not new: a recent search uncovered similar resolutions adopted by faculties at the <u>Boston University</u>, <u>Massachusetts Institute of Technology</u>, <u>Oberlin College</u>, <u>University of Kansas</u>, <u>University of Virginia</u>, and most recently, <u>Duke University</u>.
