Joyner Library is integral to East Carolina University's ability to accomplish its mission through education, research, creative activities, and service. For students, one of the most visible contributions has been 24/5 Library

As my time as Provost and Vice Chancellor for Academic and Student Affairs draws to an end, I have had the opportunity to reflect on the changes that have taken place at East Carolina University during the seven years I have been in this position. Joyner Library certainly has seen its share of transformations, from physical modifications that increased and enhanced quiet study space as well as space for collaborative work and exhibits to innovative technologies such as mobile interfaces, responsive web design,

Despite tough economic conditions, Joyner Library continues to provide online access to significantly more books, primary source documents, and journals than it did in 2007. Joyner Library has found ways to recognize student and faculty excellence in research and writing, ranging from an award for first-year students to an annual ceremony recognizing faculty

members who publish scholarly monographs. And it does all this with a smaller staff and operating budget than it had in 2007!

I congratulate the Joyner Library faculty and staff on their commitment to excellence and service in the finest tradition of ECU. I want to encourage you to join me as a financial supporter of Joyner Library. In these tight budget times, private support is essential to the continued growth of our Library and University.

The 2014 Joyner Library Annual Report highlights some of the individual and collective achievements of my Library colleagues this year. Through collaboration and hard work focused on a shared mission, we accomplished many of our long-term goals. We created the Janice Hardison

Faulkner Gallery, opened the Library 24/5 hours during the academic year, expanded campus partnerships, and renovated the first floor entrance area with new service desks, exhibit cases that promote our special collections, additional seating, and a Starbucks. We added unique primary resources, historic maps, digital collections, e-journal backfiles, streaming media, and other resources needed by our faculty and students. We enriched the quality of life for our students and our region through our exhibits and events. We even had a Homecoming float!

The dedication of our staff was illustrated on Sunday, June 29, when a major water leak occurred early in the morning. Within two hours, approximately 30 employees were at the Library, salvaging materials, carting emptied wet boxes to the dumpster, hanging plastic, and moving furnishings out of harm's way. This joint effort helped minimize the damage to the facility and our collections. And, as one librarian put it, "everyone present – faculty, staff, contractors -- was working on the same team, on the same project, at the same time. Remarkable! I enjoyed

the exercise, the camaraderie and the joint effort." Although it is not always as easy to see, that same camaraderie and joint effort goes into the smooth functioning of the Library every day. Thanks to the faculty, staff, and student workers who make it happen!

Private support is critical to the Library's ability to achieve its mission. We thank the donors profiled in this year's annual report and our other donors – past and present – who have contributed funds, manuscripts, materials, and their time to the Library. We are looking ahead to our next major fundraising project – a much-needed renovation and expansion of the Music Library. The project will include two new group listening/viewing rooms, a quiet study area, a new computer area, and expanded comfortable seating. It has been my pleasure and privilege to have served as your interim dean this year. Thanks for the opportunity to share the accomplishments of the Library with you and thank you for your ongoing support.



Janice Hardison Faulkner Gallery Dedication

Former North Carolina Governor James B. Hunt Jr. was among those in attendance Tuesday, March 11th when a renovated gallery and study space in Joyner Library was dedicated to honor East Carolina University alumna Janice Hardison Faulkner.

The Joyner Library Advancement Council selected the Janice Hardison Faulkner Gallery as its flagship project in fall 2012. Chartered in 2010, the council provides advocacy, consultation, and opportunity for involvement with library initiatives.

Council members, then chaired

by Harry W. Stubbs IV and vice chair Michael D. Priddy, launched a campaign that raised in excess of \$130,000. More than 125 donors rallied behind the cause.

In an interview with ECU News Services published in December 2012, Faulkner said of the project: "One of the first things we do when we're separated from home as college students is to build a little nest, a place that is familiar and comfortable, and meets the requirements you're looking for like a quiet place to study or a place to put your feet up

while you read. So it (the gallery) has an ambiance that is missing from the strictly academic structures (on campus)."

Among her many accolades, Faulkner was recognized by ECU in 1993 with its Outstanding Alumni Award and in 2007 as one of ECU's 100 Incredible Women by the ECU Women's Roundtable. She received the Jarvis Medal in 2009, East Carolina's highest honor, and in 2012 received the State of North Carolina Award, the highest civilian award given by the state.

About the Gallery

The Janice Hardison Faulkner Gallery is a dynamic space that will serve a variety of needs. The 3,700-square-foot gallery area will accommodate up to 200 guests.

State of the art technology includes two 80-inch LCD panels for digital art, two projectors with 100-inch retractable screens and 16 ceiling speakers. Art will be displayed with an AS Hanging System.

When not in use for planned events, the space will be furnished with comfortable seating for student study.

The total project cost was \$275,000 with funding also provided by ECU's Division of Academic Affairs, Joyner Library and the Fred Timms Langford and Verona Lee Joyner Langford Endowment.

Stuart Wright Collection Enriches Research and Learning

Poetry

“Archival Explorations: Ongoing Research in the Stuart Wright Collection” brought ECU students and faculty to Joyner Library on February 4 for presentations on Southern literature. Jan Lewis, Interim Dean, and English Professors Alex Albright and Tom Douglass welcomed students and staff to the event, which celebrated Joyner’s acquisition of over 3,000 books and 6,000 manuscripts from noted collector and bibliographer Stuart Wright.

Dr. John Steen, a Visiting Assistant

Professor in English, presented images and anecdotes from the *Collection’s* Randall Jarrell papers in a talk titled, “Jarrell’s Beards: Masculinity, Sexuality, and Midcentury Poetry.” Three ECU students showcased research projects begun in Steen’s ENGL 5230 course last fall. Melody Ballard, Class of 2016, presented original research on death in Randall Jarrell’s unpublished poems. Joshua Pittman, English M.A. 2014, discussed the marginalia in Robert Penn Warren’s notes for *Democracy and Poetry*, and Timothy

Buchanan, English M.A. 2015, showed John Crowe Ransom’s evolving views of gender through successive revisions to his poems.


Children’s Literature

Children’s literature scholar and poet Dr. Richard Flynn delivered the closing remarks for the Mid-20th Century Children’s Literature Exhibit featuring works from the *Stuart Wright Collection* on April 10th. The exhibit, was organized by Rare Books and Manuscripts and the Department of English, and included items by John Updike, John Ciardi, Katherine Anne Porter, Eudora Welty, Richard Wilbur, Garth Williams, Mark Strand, Maurice Sendak, and Randall Jarrell. Jonathan Dembo curated the exhibit

and Alan Bailey organized the event lecture.

Flynn’s lecture, “Randall Jarrell’s Cross-writing and Mid-Twentieth Century Children’s Literature,” was based in part on primary material held in the *Stuart Wright Collection* at Joyner Library. Dr. Flynn is Professor of Literature at Georgia Southern University and a specialist in contemporary American poetry and children’s literature. Dr. Flynn plans to compile

and publish a new collection of poetry by Randall Jarrell consisting of previously unpublished poems that are part of the *Stuart Wright Collection*.

Fear of Flying

To celebrate the 40th anniversary of the publication of Erica Jong’s novel *Fear of Flying*, the Manuscripts and Rare Books Department, in cooperation with Professor Tom Douglass of the English Department, mounted an exhibit of Erica Jong’s work in the exhibit cases

in the first floor lobby.

Fear of Flying, published in 1973, was Jong’s first novel, and was received with both great acclaim and scorn for its tradition-shattering depiction of female sexuality.

The copy of *Fear of Flying* on display was a signed presentation

copy that Jong gave to the poet Mark Strand, who had been her teacher at Columbia University. The book is part of the *Stuart Wright Collection*. Among Jong’s other works featured in the exhibit were *Half-Lives* (1973), *How to Save Your Own Life* (1977), and *Witches* (1981).

Gift to the Teaching Resources Center

Long time East Carolina University and Joyner Library supporter, Ann Rhem Schwarzmman has given \$50,000 to name a room in the Teaching Resources Center. The Ann Rhem Schwarzmman Enhancing Teachers' Classrooms Production Room, located on the second floor, is designed to assist in the creation and preparation of materials used in lesson units, classrooms, and presentations.

When asked why she chose a naming opportunity in Joyner Library, Mrs. Schwarzmman said, "the library is the heart on a college campus. Every department uses the library in some way and an attractive classroom can enhance a very good learning environment."

Mrs. Schwarzmman '57 BS, '58 MA dedicated her teaching career to elementary students. She taught first and second grades for many years. Then she returned to East Carolina University to become certified in

learning disabilities. Ann established the LD program at Southwood and Pink Hill Schools in Lenoir County.

Mrs. Schwarzmman is a member of the Joyner Library Advancement Council, Honors College Advancement Council, and the Friends of Joyner Library Board of Directors.

Each spring, the Rhem-Schwarzmman Prize for Student Research is given to three undergraduate who presents the best essays. Mrs. Schwarzmman began the event to encourage students to use materials from the Special Collections Department at Joyner Library and to improve their writing skills.

She has provided a scholarship for a student in the Honors College, and one for a children's theatre major.

Ann is also a member of the Women's Roundtable, the Order of the Cupola, Leo Jenkins Society, and a lifetime member of the East

Carolina Alumni Associations. Mrs. Schwarzmman was inducted in the Educators Hall of Fame and the ECU chapter of Phi Kappa Phi.




Paleontology

Audubon's Birds of North America

An ongoing series of exhibits on the first floor of Joyner Library features items from one of Joyner's most significant collections of printed materials, *A Reproduction of Audubon's Birds of North America*. The volume reproduces 50 full color, full sized images from Audubon's original 1828 publication. Each year four prints from the volume are exhibited.

The first exhibit was of the Black Billed Cuckoo, which ran from September through November 2013. It was followed by the White-headed Eagle (also called the American Bald Eagle), the Black Bellied Darter or Snake Bird (also known as the Anhinga), and the American White Pelican, the rarest and most valuable of the prints exhibited to date.

Accompanying each print is explanatory text about the history of the print and its accurate description of the behavior and natural history of its subject. A brief biographical sketch of John James Audubon is also provided.

Inaugural Faulkner Gallery Exhibit




Celebrating Faculty Authors



Librarian to Librarian Summit







Survey Results and Action Plan

Students Give Joyner a Thumbs Up in Recent Survey

Joyner Library periodically surveys students to gauge their satisfaction levels with Library resources and services and identify areas for improvement. In the spring of 2014, 1,248 students completed the LibQUAL+© survey, which was developed by the Association of Research Libraries. The survey uses a nine-point scale to measure satisfaction levels. For each of the areas measured, ECU's mean score exceeded the aggregate mean for the 165 institutions that administered the survey in 2013 (the last year for which data are available):

Undergraduate students had high satisfaction levels for *Hours of Service*,

Employees Who Are Consistently Courteous, and *Modern Equipment that Lets Me Easily Access Needed Information*. Areas with the lowest satisfaction levels included *Library Space that Inspires Study and Learning*, *Community Space for Group Learning and Group Study*, and *Quiet Space for Individual Activities*. Graduate students had high satisfaction levels for *Willingness to Help Users*, *Availability of Electronic Resources from Home or Office*, and *Hours of Service*. Areas with the lowest satisfaction levels included *Community Space*, *Inspiring Space*, and *Making Me Aware of Library Resources and Services*.

Student comments expressed appreciation for the 24/5 hours introduced in Fall 2013, but noted that it would be even better if more areas of the library could remain open. Joyner Library plans to expand 24/5 access beyond the first

floor in Fall 2014 and is also adding additional weekend and holiday hours. Students also pointed out that they have trouble finding a place to sit during busy times. This fall, the Library will use endowment income to purchase a variety of furniture that will add 158 seats, a 13% increase in capacity, throughout the building.

It is a challenge to provide a balance of quiet and group space, while also creating an environment that inspires study and learning and addresses collection needs, but it is one that we take seriously and continually assess through data, observation, and feedback.



Faculty Needs Assessment Survey

Academic Library Services, in collaboration with the Faculty Senate Libraries Committee and Laupus Health Sciences Library, invited faculty to participate in a needs assessment survey during the 2014 Spring semester. A total of 339 faculty responded, with 190 individuals (56%) indicating that they primarily used Joyner Library, 135 (40%) indicating primary use of Laupus, and 10 (3%) indicating primary use of the Music Library. While only 29% of Joyner/Music faculty reported that they visited the libraries in person every week, more than 80% said that they used online library resources at least weekly. Eighty-five percent of faculty agreed that the ECU Libraries' collections were either "Effective" or "Very Effective" in meeting their research and teaching needs. From a

list of nine items, respondents rated the ECU Libraries of most value in helping them be more productive researchers, keep current in their fields, and find information in related fields or new areas.

Faculty indicated the most interest in using the following services that support their research and scholarly activity:

- Assess the impact of my work following its publication
- Assist with copyright, fair use, and author rights questions and issues
- Provide information about publishers' open access policies and publishing fees

They also expressed strong interest in these services to support teaching:

- Online modules and/or instruction dealing with

plagiarism and ethical use of information

- Online instruction and/or remote consulting to support student learning
- Streaming media resources for instruction and e-reserves
- Class research guides for specific research assignments
- Integration of library resources into Blackboard and other campus courseware

The results of the needs assessment were used to help develop library priorities and goals for the upcoming year. The Joyner Library enewsletter will be used to keep faculty informed about progress on addressing these needs. The Faculty Senate Libraries Committee will also play an important role in communicating with faculty.

New Services and Resources

Extended Operating Hours

Like many academic libraries, Joyner had contemplated expanding its regular hours of operation to 24-hours for several years. Although the Library had expanded to a 24/5 schedule during the final three weeks of the semester for years, student demand for overnight access during the rest of the semester was still unmet.

Starting fall 2013 as a pilot project, Joyner Library began opening at 10 am on Sunday and did not close until 9 pm on Friday night. Security guards checked ID's from 11pm-7am to

ensure that only ECU affiliates were in the building and from 2am-7am only the first floor remained open. During the overnight period, more than 8,300 students entered the library throughout the fall and spring semesters. Nearly 97% of overnight visitors were undergraduate students. The most popular majors were Nursing, Biology, and Management.

The first semester of 24/5 operating hours at ECU was exceedingly successful by almost all measures. Anecdotally, students were extremely appreciative and positive

about the 24/5 access. Based upon the quantitative level of usage and qualitative data of student goodwill, the hours will be implemented permanently during the 2014-2015 academic year. For the fall 2014 semester, the Library is examining the possibility of leaving more floors open during the final weeks of the semester.

Digitizing Football Films

As East Carolina embarks upon its inaugural season in the American Conference, the University Archives in conjunction with Digital Collections is proud to announce the digitization of our entire holdings of football game day programs and 16mm film reels. The digitized game day programs cover a period of 60 years from 1935-1995.

The 16mm films cover the period from 1951-1989 and feature many of the school's revered players and coaches competing on behalf of East Carolina. The digitization process will prevent the loss of Pirate football history owing to acetate film degradation, commonly called vinegar syndrome.



Special Collections Shine with New Acquisitions

Joyner Library's North Carolina Collection is one of the state's major repositories dedicated to the study of North Carolina, its culture, and its people, and is the only one to emphasize the eastern region of the state. This year, the NC Collection added first editions of several novels with settings in North Carolina. These include the extremely scarce story of pre-revolutionary North Carolina, *Alamance or, the great and final experiment* (1847) by Calvin Henderson Wiley; the 1904 science fiction novel *Maître du Monde (Master of the World)* by Jules Verne, complete with a mad scientist on the loose near Pilot Mountain; and the modern classic, *On the Road* (1957) by Jack Kerouac.

As part of ongoing efforts to expand the comprehensiveness of the Roberts Collection of North Carolina Fiction, the NC Collection acquired over 400 issues of the dime novel series *The Liberty Boys of '76*. In marketing design, such serial publications are the precursors of comic books. Our collection of this title is now larger than that reported

by any other library.

The NC Collection continued to benefit from the support of the Pulitzer-prize winning journalist, Gene Roberts. His donations this year included 25 rare titles devoted to the Civil War and eastern North Carolina. Among the scarcest items was a federal government broadside detailing the requirements for merchants wishing to operate in Union-occupied areas of North Carolina.

The East Carolina Manuscript Collection and University Archives also benefited from the generosity of donors. University and community leaders including Alex Albright, Max Ray Joyner, Liz Sparrow (W. Keats Sparrow Papers), Joseph Steelman, Earl Trevathan, and David J. Whichard II donated their papers to the Library for the benefit of future researchers. Oral history interviews conducted by Professor Jonathan Dembo captured the recollections of other current and retired faculty members. A number of families and organizations gifted their papers to the Library, including the Robert May Family, the family

of William B. Martin, and Concord Primitive Baptist Church (located near Creswell, NC). The daughters of Vice Admiral Robert L. Ghormley delivered a valuable addition to their father's papers in June.

Other important acquisitions and gifts this year include letters written by Civil War soldiers who fought in the First Battle of Kinston, a 1706 map illustrating Ponce De Leon's travels and discoveries in North and South Carolina, and a 1862 map of the Civil War battlefield of Roanoke Island.

Maritime Studies Conservation Class

Introduction to Archaeological and Museum Artifact Conservation (HIST 6840) utilizes both classroom and laboratory experience to provide history and anthropology graduate students a comprehensive introduction to the history, ethics, and techniques used by conservators in laboratory and field environments. As part of their coursework, students conduct interviews and produce short videos introducing a conservation method or concern. In their video “Preserving Your Memories: Photo Conservation,” Maritime History graduate students Allison Miller and Melissa Price interviewed Joyner Library Special Collections conservator Lynette Lundin, who provided a brief history of photography and described the basics of caring for photographs. Archival Administration

Introduction to Archival Administration (HIST 5910) has been taught jointly by the History Department and Joyner Library since the 1980s. Designed for history majors, it focuses on archival practice and procedure. The classes are small (4 – 14 students) and there are no exams. The students earn their grade by processing a manuscript collection. Since 2001, the Library has posted online 125 finding aids processed by HIST 5910 students. That is almost 10% of all the collections processed since the Department began.
